WHEREAS the RM of Stuartburn is home to many endangered species (approximately $\frac{1}{2}$ of the municipality) which limits the timing of road works being done such as invasive species spraying, roadside mowing as well as drainage works;

AND WHEREAS in previous years Council has been working with Manitoba Sustainable Development Staff in the Habitat and Endangered Species Section and Manitoba Tall Grass Prairie Preserve to help

identify and mark out the areas where endangered species are so that timely roadside mowing can transpire before snow fall;

AND WHEREAS Council has recently received notification from Manitoba Tall Grass Prairie Preserve that no marking of endangered species will transpire this year further indicating that if the road is highlighted in the Manitoba Species at Risk booklet as being a designated roadside that supports endangered species, the municipality is restricted from mowing the whole section of road until after the September 30th deadline;

AND WHEREAS Council is extremely disappointed that they no longer have a working agreement with Manitoba Sustainable Development – Habitat and Endangered Species Section and Manitoba Tall Grass Prairie Preserve;

AND WHEREAS Council is concerned that waiting until that late in the year to provide roadside mowing is a safety risk to our ratepayers due to potential early snowfalls creating the risk of snow drifting making roads impassable or unsafe for travel;
