- ➤ CBSA Meetings CBSA standing firm on cutting hours
- ➤ Elk Hunting Reeve Kiansky is requesting a meeting with Premier Pallister to discuss hunting rights of Elk in the RM of Stuartburn.
- ➤ Commercial Subdivision near Vet Clinic area was never zoned commercially, only 2 lots remain, council to look at redesignating the land during development plan review to create more lots
- ➤ Tree cutting on road allowances CAO confirms with council that the trees belong to Sustainable Development and a permit is required from them.
- ➤ Drug problems & Theft in town CAO to request a meeting with RCMP
- Canada Day Committee brief discussion on rec director, new board members potentially joining Canada Day Committee
- > 55 Plus discussion need to pursue developers to come develop in Vita
- ➤ Age-Friendly sidewalk discussion, install corrugated black pipe, fill in ditches, propose to do in phases CAO to inquire with other RM's that have done this for pros & cons as well costs involved in this.
- ➤ Day use campground @ farmer's market area with bathroom this area is open for usage by the public currently, look into signage for now, council to investigate further development in 2019 budget
- ➤ Ditching Project between township 1 & 2 along 6N to Sundown South Swamp phase 1 would be to cut brush in road allowance, CAO to look to see if there are any surveys of the area, request SRRCD to do lidar study first
