AND WHEREAS administration has been in contact with the PUB in regards to the 2019 utility deficit application;

AND WHEREAS PUB has indicated to submit another application to the PUB with the actual 2019 utility deficit with method of recovery along with explanations for the delay in providing the information and reason for the deficit;

THEREFORE BE IT RESOLVED that Council hereby applies with the required explanations to the PUB to recover the actual 2019 utility deficit of \$36,469 by way of rate rider over of \$56.28 per residential equivalency unit over a 2 year period. Carried
